

# CATBOX CLASSIC BEACH VOLLEYBALL INVITATIONAL

## TEAM CONTRACT FOR THE 2026 EVENT

This contract made and entered into on the \_\_\_\_ day of \_\_\_\_\_, 2026, between the school authorities in control of Interscholastic Athletics at (hereinafter Tournament Participant) and the school authorities in control of Interscholastic Athletics at Ironwood Ridge High School and the Amphitheater School District (hereinafter Tournament Committee) stipulates the following:

- 1) That that High School Varsity Beach Volleyball team representing \_\_\_\_\_ shall compete in the **CatBox Classic Beach Volleyball Invitational**, to be held on **March 27-28, 2026**, at **Ironwood Ridge High School in Oro Valley, Arizona, and Amphitheater High School in Tucson, Arizona.**
- 2) The **Tournament Entry Fee of \$675 will be payable to Ironwood Ridge Beach Volleyball**, and the Ironwood Ridge High School Bookstore shall receive it on or before **March 13, 2026**.
  - a. *Purchase Orders will be accepted before March 13, 2026, to secure registration.*
  - b. ***The Entry Fee includes one school team (six pairs) for the team dual competition; and five pairs for the pair's competition. Additional pairs may be entered if the tournament field has room.***
- 3) **The Tournament Participant agrees with the following policies and procedures:**
  - a. The Tournament Committee shall have sole responsibility for the tournament format.
    - i. **Friday: Team Duals** (Three-Team Pools)
    - ii. **Saturday: Pairs Competition** (Power Pool for the top eight seeds; four-team pools)
  - b. The Tournament Committee will seed the field in groups that best match the strength and ability of the participating teams and pairs.
  - c. The Tournament Participant agrees to play in all matches set forth in the schedule.
  - d. The Tournament Participant is guaranteed two dual matches; and four (4) pairs matches/sets.
  - e. **The Tournament Committee will provide AIA Officials for all matches.**
  - f. **The Tournament Committee will provide a licensed Athletic Trainer at all venues.**
  - g. **The Tournament Participant agrees to have a school-board approved coach at each site during the competition.** Failure to provide an approved coach will result in the team/pairs being disqualified.
  - h. The Tournament Participant agrees to informing all school spectators (parents, family members, students, etc.) of the Spectator Code of Conduct – found on the tournament website.
- 4) For this contract to be valid, the Tournament Participant must sign and return it to the Tournament Director on or before **March 1, 2026**. The Tournament Participant must also understand and agree that this contract will bind them to the above agreements. The tournament cannot revoke this contract once both parties have signed it.
- 5) The term of this contract shall be from the date of execution until the tournament's conclusion on Saturday, March 28, 2026.
